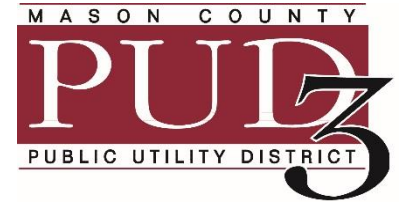

Ductless Heat Pump Customer Checklist

Qualifying single-family, site-built homes and manufactured homes must have an electric forced air furnace or zonal electric resistance heat as its primary heat source. To see if your home qualifies, please contact the PUD 3 conservation department at (360) 426-0777. Manufactured homes must be 1977 or newer to qualify.

Choose a licensed contractor who attended a Northwest Ductless Orientation and received installation training from the manufacturer of the installed ductless heat pump equipment. A partial list of installers can be found at www.goingductless.com or at the PUD 3 conservation office. PUD 3 recommends getting at least three quotes.

The ductless heat pump system you have chosen must be listed on the Bonneville Power Administration (BPA) qualified ductless heat pump list found at www.bpa.gov/. The ductless heat pump must be installed according to the manufacturer's specifications and the [Northwest Ductless Heat Pump Best Practices Guide](#).

If your home has existing duct work, PUD 3 strongly recommends the duct work is tested and sealed according to the [duct sealing](#) program requirements. An incentive may be available.

Please ensure that the installing contractor and/or electrician secure a Washington State Labor & Industries (L&I) electrical permit AND a Mason County or City of Shelton mechanical permit BEFORE installation. Copies of the final and approved permits will be required before PUD 3 incentives can be paid. Manufactured homes only require L&I permits.

Once your new ductless heat pump is installed, the certified contractor must fill out and submit a Ductless Heat Pump Installation Form to the PUD 3 conservation department. This form can be found at www.pud3.org/ductless.

A copy of your invoice showing the make and model number of qualifying equipment is required.

Once your new ductless heat pump is installed, schedule an equipment installation verification appointment with the PUD 3 conservation department at (360) 426-0777. This may also be a good time to have the PUD 3 energy efficiency advisor inspect your home's insulation levels.

When all the necessary information is collected, verified, and approved, PUD 3 will process the incentive check to either the customer or the contractor, as specified by the customer. Please allow six to eight weeks for payment delivery. One reimbursement per residence is allowed.
